1/23. Apologies for Absence – I. Johnson.

2/23. Code of conduct – localism Act 2011

3/23. Minutes of the Parish Council meeting held on the 13th February 2023.

4/23. Matters Arising – Actions.

Ref 122/22 – Cllr Jarvis had received a reply from HSBC in regard to the closure of the Settle branch and alternative banking provision at the Post Office, the Chairman had been made aware that the Settle branch of HSBC was to close in September.
